
The Pavilion is on Long Island Sound, dress warmly! Covid protocols as per State of CT in May.

## **NEWC** to Hold Exhibit at the Sailfest in New London, CT

Sailfest 2022 will be held July 8-10, 2022. Sailfest is Southeastern CT's premiere summertime event, complete with a major fireworks display, amusement rides, free entertainment, ships and over 200 vendors lining the streets. There will be plenty to see, buy and eat. So make sure to come hungry and ready to try new food!

NEWC and the Thames River Gallery on 239 Banks St., New London, CT 06320, 800-443-0344 will partner to present an exhibit of Master Carvings on July 8-10. NEWC members who have entered carvings in the Master Class Competitions or NEWC members who have done a carving they believe has appeal, quality, and merits exhibition are invited to enter their work for exhibit. This Sailfest is visited by over 300,000 people. Banks St. and others will be closed to vehicle traffic so thousands of pedestrians can walk around and view all the venues. The Gallery is working with Christopher LaMontagne to do a chainsaw carving of a lighthouse. Chris's work can be seen on YouTube.

The Sailfest organizers and John Johnson who is a well-know art dealer and owns Thames River Gallery are excited to work with NEWC and will promote our exhibit in their publicity campaign. This is your chance to show your work in a high-quality studio.

Friday, July8th will be used to set up the Exhibit and will be the last day to register if there is space. Register early, bring your carving(s) early on Friday so it will be ready for the heavy tourist traffic which begins in the afternoon. Your carving(s) can be dropped off at the Gallery as early as a week before the Exhibit or earlier if you make arrangements with the staff.

If you wish to enter there will be a registration form on the NEWC website (www.newc.org) with entry fees and guidelines. All entry fees go to NEWC. Layout and positioning decisions will be made by the Gallery staff.

Thirty six years ago, the Valley Shore Waterfowlers began partnerships with wildlife artists, woodcarvers, carving clubs and others in fund raising to promote projects related to wildlife conservation –especially waterfowl, Now after many seasons and events, time is catching up with us waterfowlers. We are considering one more event which was laughingly called the LAST PICTURE SHOW. What we would hope to do is invite back everyone who has loved this for one more time. We're gathering at the Pavilion of the Westbrook CT Elks on Saturday, May 21st, from 10am to 3pm. As we did in "21" we partnered with a group called the BOYS DECOY NETWORK. We expect to have some 26 tables of decoy collectors joining us.

#### Entry fees -\$5.00first, \$2.00 thereafter to \$15.00, all additional are free.

Decoys begin this event -here are the rules. This, as far as ducks (I-IV) are concerned, is an open competition-one level decoys. All ducks are floated, must self right. IWCA rules apply for painting, Categories are puddle ducks, divers, sea ducks and goose/confidence. No raised primaries.

- I. Working Decoys -minimal paint and carving.
- II. Decorative working decoys (smoothies) IWCA paint and detail carving on heads.
- III. Canvas Birds—stretched canvas over wood or wire frame.
- IV. Shorebirds (2 categories natural finish, painted finish, choice of feet or sticks).

Awards duck categories, ribbons to 1st, 2nd, 3rd, in species best class \$25 plus rosette, best in show \$100 plus rosette.

- V. WOODCARVING -judges reserve right to modify categories according to entries
  - A. Fur -animals, mammals including whales
  - B. Fish—2 headings, fresh and saltwater (2 best of class)
  - C. Feathers—all other bird categories: song birds, raptors, game birds (no ducks) -up to 3 headings
  - D. Utility -carvings that function, i.e. kitchen utensils
  - E. Caricature -no size requirement, your subject
  - F. Abstract (sculpture) unlimited artistic interpretation
  - G. Miniature anything, can include ducks max length 6"
  - H. Youth any subject, age limit 16 years
  - I. Relief, high or low

Awards in this category are ribbons to 1st, 2nd, 3rd in heading, best in class \$25, best in show \$100, 2nd best rosette and 3rd best rosette.

Any carver or collector who would like to support the show by adding a decoy to the auction may do so. Entry fees are waived for carvers who do so. Auction proceeds are shared 50/50. A \$5.00 calling for the auctioneer will be covered by the show.
